# Yom HaShoa Program:

#### Teaching the Holocaust Through Music

Dr. Ludmilla Leibman, a professor of music at Boston University, will speak on "Teaching the Holocaust through Music" at the synagogue's Yom HaShoa program on Sunday, April 18th at 7:30 PM. Everyone is cordially invited to attend.

Dr. Leibman's talk addresses the cultural policies of Nazism as they applied to music, the music of the ghettos and concentration camps (which reflects the spiritual resistance of the Jews), and will conclude with a survey of music composed after the Holocaust by Jews and other victims of Nazism.

Dr. Leibman was born in Russia and graduated magna cum laude

After immigrating to the United States in 1991, she received her Doctor of Musical Arts degree from Boston University, where she teaches music theorv. Her doctoral dissertation, "Teaching the Holocaust through Music," became the basis for a new interdisciplinary course at BU Dr. Leibman is also the director of the Educational Bridge Project, which she initiated in 1997 as an international exchange program between musicians of the United States and Russia.

# **Preparation** for Annual Shul Elections

In accordance with the Bylaws of the Synagogue, preparations are being made for the elections and other voting that will be held at the annual Congregational Meeting ("the Meeting"), which will be held in June. The Board of Directors has selected a Nominating Committee ("the Committee") that will officiate at the voting. In accordance with the Bylaws, three members of the Committee are members of the Board of Directors and two are non-Board members. The members of this vear's Committee are Board members Leonard Berman (committee chair), Harvey Lipsky and Saul Aronow, and non-Board members Harold Binder and Sarah Wagner.

Each year, all officers of the shul (President, Vice-President, Treasurer, Clerk) and two of the six Directors (who serve for three-year terms) are elected. The Committee will prepare a slate of recommended candidates. If a member wishes to nominate alternate candidates, s/he should submit the names to the Committee at least 15 days prior to the Meeting, as a petition signed by at least 10 members and containing a statement by the candidate that s/he would serve if elected. Please contact Leonard Berman. Chairman of the Committee, if you are interested in presenting alternative candidates. The Committee will prepare ballots for the Meeting with all eligible candidates.

# Passover Guidelines

#### Sale of Chometz:

In preparation for Pesach, one must rid their home and other properties entirely of all chametz. Any chametz not destroyed must be sold to a non-Jew before Monday, April 5th. A rabbi is appointed as an agent for the owner of the chametz to sell it to a non-Jew. Not only does one sell the chametz in their possession, but the property on which the chametz is located is also subleased to the non-Jew. This procedure is not a legal fiction, but a true sale in accordance with Talmudic and secular law.

Rabbi Zalman will be available at the shul for the sale of chametz on Saturday evening, April 3rd after Havdalah, and Sunday morning, April 4th at 9:00 AM. If you are unable to make these times, contact the Rabbi for a private appointment or fill out the "Contract for Sale of Chametz" (included in this newsletter) and fax to Rabbi Zalman at 617 244-4667 before Sunday evening April 4th. The Rabbi can not accept chametz for sale after Sunday, April 4th. All chametz sold by Rabbi Zalman shall be considered sold as of Monday, April 5th at 11:42 AM, and may be reused only after 9:00 PM on Tuesday, April 13th.

#### Sunday, Erev Pesach, April 4th

Bedikat Chametz - the Search for Chametz should be done after nightfall, the earliest time for which is 7:33 PM. The custom is to "hide" pieces of bread for the search. The blessing and the concluding formula may be found at the beginning of most Haggadot. Although, we search for the "10 pieces of bread," (which can be placed in tin foil or bags to avoid crumbling), Bedikat Chametz is supposed to be a bona fide search through drawers, coat pockets, and purses. Cars may be cleaned well under sunlight and need not be searched. The halakhah requires that the search be done by additional illumination (candle or flashlight).

#### Monday, April 5th

All eating of chametz must cease by 10:38 AM. (Matzah may not be eaten until the Seder.) Burning of chametz must be performed by 11:42 AM.

Candle Lighting at 6:57 PM Seder may start at 7:44 PM

#### **Burning of Chametz:**

Chametz is burned on the morning of Monday, April 5th by 11:42 AM. (All chametz that was sold to the rabbi must be closed and stored away.) Upon throwing the chametz into the fire, one recites in Aramaic and English, "All chametz and leavening that may still be in my property which I have not seen or have not removed, or whose existence I have no knowledge of, shall be null and disowned and deemed valueless as the dust of the earth."

#### **Fast of First Born Males:**

Monday, April 5th is a fast day for first-born males, reminding us how G-d

spared the Jewish first-born from the 10th plague in Egypt. Traditionally, one may break this fast by attending a festive meal in honor of completing the study of a Talmudic tractate (siyum). Such events are held in various shuls around Boston on the morning of April 5th.

## Minimum Requirements for the Seder:

One must have a required minimum of one Kazayit (1 ounce) of Matzah for the Seder (approximately half of board of matzah), 3/4 ounce of Maror and 4 cups (5 ounces each) of wine or grape-juice.

It is preferable to use round hand baked Shmurah matzah for the Seder. The difference between Shmurah and non-Shmurah matzah is in the degree of stringency that was invested in the preparation of the flour. Jewish law requires us to protect the flour from coming in contact with water prior to its baking. Most authorities

## CERTIFICATE AUTHORIZING THE SALE OF CHAMETZ

Since it is prohibited to posses chametz on Passover, we must sell to a non-Jew all chametz that will not be eaten or burned and all chametz utensils that were thoroughly cleaned before Passover. These are stored away in closets or rooms while preparing for Passover. These closets/rooms will be leased to the non-Jew at the time of the sale. Since there are many legal intricacies in this sale, only a competent Rabbi should be entrusted with its execution. The Rabbi acts as our agent both to sell the chametz on the morning before Passover starts, and then to buy it back on the evening after Passover ends.
